



Facility Emissions of Health-Risk Air Pollutants in the Town of Oakville

As part of the town’s commitment to improve air quality in Oakville, the town passed the [Health Protection Air Quality By-law 2010-035 \(HPAQB\)](#) on February 1, 2010. Under the HPAQB, facilities in Oakville that emit above the “negligible quantity” of any health-risk air pollutant are required to submit an emission report to the town.

Volatile Organic Compounds, VOC	10	10,000	Combustion from vehicles and stationary sources, fuel-refilling, general solvent use, industrial processes, such as paint/coating application, petroleum refining, plastics manufacturing, food processing, agricultural activities, and wood processing and burning.

This requirement to report provides disclosure to the public of information on local health-risk air pollutant emissions from local facilities in Oakville. This feature of the HPAQB is similar to Toronto’s Environmental Reporting and Disclosure By-law.

In addition to industrial processes, other local sources of health-risk air pollutants come from vehicle emissions and operating buildings. Everyone can take action to improve our air quality by using their vehicles less, using active and public transportation, and practicing energy conservation to use less energy for appliances use and to heat and cool homes.

The town has adopted and implemented the following green initiatives and best practices to reduce health-risk air pollutant emissions from the town’s facilities and operations:

- [Anti-Idling By-law 2002-153](#) – controls vehicle idling in Oakville.
- [Climate Change Adaptation Strategy](#) – creates a corporate Climate Change Adaption Plan
- [Corporate Energy Management Plan](#) – provides energy actions and best practices, as well as energy efficiency targets.
- [Energy Conservation Outreach Program](#) – Annual Conservation Fair, Earth Hour, BIA ‘Doors Closed’ campaigns.
- [Environmental Strategic Plan](#) – outlines actions to improve the environment in Oakville.
- [Environmental Sustainability Plan](#) – promotes environmental initiatives advancing Oakville as a sustainable community.
- [New Communities of Oakville](#) – develops a transit-first, sustainable, walkable community for lands north of Dundas.

- [Livable Oakville Official Plan](#) – growth directed considering sustainable development principles to protect the natural environment, heritage and stable neighbourhoods, and green community development and building. For example, new town buildings over 500 m² are to be built to achieve [LEED](#) Silver certification.
- [Partners for Climate Change Protection \(PCP\) Milestone Program](#) – committed to a corporate operations greenhouse gas (GHG) emissions target of 20% below 2004 levels by 2014.
- [Private Tree Protection By-law 2017-038](#) – preserves significant trees on all private properties within the town and to sustain Oakville's urban forest.
- [Sustainable Building Design Procedure](#) – reduces emissions and improves energy efficiency for new and existing facilities.
- [Sustainable Green Fleet Procedure](#) – reduces emissions and improves fuel efficiency for vehicle operations.
- [Sustainable Purchasing Procedure](#) – promotes purchasing sustainable products and services that lessen environmental impacts.
- [Towards Zero Waste Procedure](#) – improves waste reduction and diversion efforts for town's operations and events.
- [Transportation Master Plan](#) / [Active Transportation Master Plan](#) – establishes transportation policies and infrastructure plans for all travel modes in Oakville (vehicles, transit, cycling, walking).
- [Transit Service Improvements](#) – Improved, more fuel-efficient routes for better service, PRESTO farecard.
- [Urban Forest Strategic Management Plan](#) – establishes policies and actions to effectively manage “green infrastructure” and increases overall canopy cover in Oakville.

Similar to facility specific improvements, these policies and procedures are implemented across the corporation and they will improve Oakville's livability through actions supporting resilience and sustainability.

- whether the facilities are sources of major emission as defined in the by-law; and
