**90A INTERIM USE PROVISIONS FOR PARTICULAR PARCELS OF LAND**

The general provisions and special provisions of this by-law as they affect the lands described or referred to in the subsections of this Section are modified to restrict uses to those shown, and to require compliance with the regulations shown, in the subsections dealing with the particular parcels of land.

The address or other indication of location is listed in the left margin and is not part of this by-law.
