- If partnership, provide list of names, date of birth and address for each partner.
- A letter from the Property Owner validating or demonstrating the applicant's right to possess or occupy the premises as an adult entertainment establishment.
- A Certificate of Occupancy, obtained from Building Services. Contact zoningrequests@oakville.ca
- Certificate of Public Liability Insurance in the amount of two million dollars (\$2,000,000). The Town of Oakville and address **must** appear on the certificate as either "**Additional Insured**" or "**Certificate Holder**" in order to provide the Town at least ten days' notice in writing prior to cancellation, expiration or change of policy.
- Original Canadian Criminal Reference Check issued by an accredited Canadian Police Service, no more than 30 days old at the time of the licence application.
- Two pieces of original Identification, such as a birth certificate, valid driver's licence or Ontario Identification card.
- Provide a list of all operators/attendants include; first, and last names and birth dates.
- A certificate issued by the Fire Chief for the Town of Oakville indicating compliance with all applicable provisions of the **Fire Protection and Prevention Act**, 1997. To arrange your inspection contact Fire Prevention at 905-338-4404.
- Provide a copy of their valid Liquor License issued by the Alcohol and Gaming Corporation.
- Provide details of hours of operation and the fee schedule including admission fee and services offered.
- A Certificate issued by the Medical Officer of Health for the Region of Halton indicating compliance with all applicable provisions of the Health Protection and Promotion Act and regulations thereto (long form Food Premises Inspection Report). The Medical Officer of Health may be contacted at the Region of Halton: (905) 825-6000.

- Incomplete applications will not be accepted and will be returned.
- It is an offence to operate a business without a licence and charges may be laid without additional notice.
