- A declaration including:
 - o A detailed list of the goods, wares or merchandise to be offered for sale, including the cost price thereof and approximate retail value.
 - o The names and addresses of persons from whom goods were purchased and the date of purchase.
 - o Particulars of the ownership of the goods to be sold if they are not owned by the applicant and the relationship, if any between the owner and applicant.
 - o Particulars of any damages or other deterioration caused to the goods by fire, smoke, water or any other means.
 - o Particulars of the information to be included in any sign, pamphlet, flyer or other advertisement to be displayed, distributed, announced or published by any means before or during the sale, purporting to indicate the reason for such sale.

- Incomplete applications will not be accepted and will be returned.
- It is an offence to operate a business without a licence and charges may be laid without additional notice.
