### Seniors' Working Action Group (SWAG) - We're Age Friendly

1. **Call to Order:** by Darlene Cox – 1:30 p.m.

**Guest Speaker:** Councillor Tom Adams, Councillor Jonathan McNeice Following the budget slideshow presented by Councillor Adams, the committee asked the following questions:

Q: Does the town still collect Development Charges?

- Town collects development charges (DCs) to support infrastructure like roads, recreation centres, and fire stations.
- DCs don't cover full costs but contribute significantly.
- · Recent provincial changes include:
  - Delaying collection from upfront to occupancy.
  - o Reducing DCs and parkland requirements.
- Concern raised about aligning development pace with infrastructure capacity.

### Q: Is the town planning to implement a hiring freeze?

- No hiring freeze planned.
- Staffing levels will be adjusted based on community needs.
- Growth areas may see increased staffing (e.g., fire services, recreation).
- Some headcount increases reflect services downloaded from the Region.

# Q:Can you provide more information regarding your Senior Fitness Fees & Discounts slide?

- No current plan to raise the 50+ age threshold for senior fitness classes.
- Ongoing discussion about age-based vs. needs-based subsidies.
- Rec Connect offers income-based support; many municipalities shifting to this model.
- Concerns raised about 50 being a low cutoff and seniors hesitant to apply for needs-based discounts.
- Council acknowledges the importance of balancing financial need and age.

### Discussion: Recreation & Health Integration

- Some fitness programs recover costs; senior discounts around 20%.
- Desire from SWAG to better integrate recreation and health services.
- Oakville is recognized for senior programming but SWAG wants to improve; current pricing structure is confusing (seniors membership 50 yrs but 65 yrs for fitness discount).

- Discussion on whether discounts should be increased or better targeted.
- Q: Discussion regarding Library & Parks Synergies
  - Appreciation for Oakville and Burlington libraries.
  - Libraries and Parks & Rec operate separately; potential for cost efficiencies; looking for greater library collaboration across region.
  - Challenges remain with digital material sharing and governance structures.

Questions around Rain Water, Property Assessment, Automated Speed Enforcement and Property Tax Deferral (to allow for Reverse Mortgages) also took place.

During the presentation, Rachel mentioned that the conversation around age thresholds, fees, and discounts will be addressed through the development of the Older Adult Strategy. This was a key recommendation in the recently approved Recreation and Culture Master Plan. There were some conflicting suggestions from the group in each of the different areas.

After the presentation, staff thanked the Committee for their thoughtful feedback and highlighted how important the Older Adult Strategy will be in helping us move forward with a clear direction around the issues discussed during the presentation—one that is shaped by input from the community and our key stakeholders like SWAG, the Policy Review Board, and our Older Adult Centres. We also shared updates on our Synergies Project, highlighting the collaboration between the OPL, SSU, Culture and Recreation lines of business, as well as the strengthened partnership with Oakville Trafalgar Hospital and the new Stronger and Steadier program.

Aquatic Aqua Adapt Staff Training Early Fall Season The Aquatics team has expanded a summer pilot of Aqua Adapt training this fall to over 60 instructors, equipping them with strategies to adapt swim lessons in ways that leverage the sensory regulation benefits of the aquatic environment. This approach not only supports inclusion but also enhances overall program delivery and swim lesson development.

**Update to IRCC Pool Renovation**: We are pleased to share that the General Contractor has committed to turn back the pool to the town on Friday, October 10. Once returned, our Facilities team will begin preparing the natatorium, which includes filling and balancing the pool, testing the air handling system, meeting all regulatory requirements, and completing a thorough post-construction cleaning. A shortened aquatic lesson session has been scheduled to begin on November 1. Our aquatic programmers have created over 1,800 lesson spaces, offering a wide range of options for the community.

**Special Events Master Plan Oct 29** - The Special Events Master Plan will be presented to Council for approval. Developed over 18 months through research, consultation, and engagement, this 10-year strategic plan will guide and support special events across the town for the next decade.

# **Councillor Cathy Duddeck update:**

The Ministry of Health has advised that those residing in Long Term Care Facilities can obtain there flu vaccine, COVID booster and RSV (if applicable)

The Premier has been in the news lately indicating that he prefers to see all speed cameras being removed as he perceives it as a tax grab. However, many municipalities, including Oakville, have firm data to substantiate their continued use as they have a direct impact on speeding. Speed cameras do change location periodically and if that occurs the appropriate signage (coming soon camera use) are installed.

Halton Region recently opened the new Senior's Health Centre (called PACE) with new housing units above the offices. 54 new housing units are being provided and fully accessible.

Kerr and Bronte Streetscaping reports were received and approved at Monday night's Council meeting. This will improve the streetscaping (lights, benches. Plantings, road improvements) in each area. The next step is obtain council approval through the 2026 Budget process and the 10 year capital plan.

The previously announced Halton Provincial Courthouse is finally being reapproved for construction. This is badly needed as the current courthouse, in Milton on Steeles Avenue, has long outgrown that facility. Police and court officials are thrilled to know this is finally getting underway.
