THE CORPORATION OF THE TOWN OF OAKVILLE

BY-LAW NUMBER 20__-

A by-law to amend Town of Oakville Zoning Bylaw 2009-189 to make a number of housekeeping, technical and other modifications affecting various zones. (Town-initiated Zoning By-law Amendment, File No. 42.03.92)

WHEREAS By-law 2023-083 delegates powers and duties with authority from Council to the Commissioner of Community Development to approve by-laws of a minor nature under section 34 of the Planning Act with respect to certain matters, including housekeeping by-laws for the purpose of making clerical or other changes to assist in the interpretation of the zoning by-law;

WHEREAS the Commissioner of Community Development is satisfied that notice of the intention to pass a by-law to make a number of housekeeping zoning by-law amendments was given in accordance with the requirements of the Planning Act;

WHEREAS the Commissioner of Community Development has considered all oral and written submissions related to this matter and is satisfied that these comments have been appropriately addressed;

THE CORPORATION OF THE TOWN OF OAKVILLE, BY THE COMMISSIONER OF COMMUNITY DEVELOPMENT ACTING UNDER DELEGATED AUTHORITY, ENACTS AS FOLLOWS:

- 1. Within **Section 12**, **Maps**, of Zoning By-law 2009-189:
 - a) Section 12, <u>Maps</u>, is amended by replacing all zoning maps 12(1) to 12 (6) with the maps 12(1) to 12(10) and the map index as depicted on Schedule "A" of this By-law.
 - b) Map 12(3) is further amended by re-aligning the boundary of the GU sp:80 zone as depicted on Schedule "B" of this By-law.
 - c) Map 12(4) is further amended by re-aligning the boundary of the P zone as depicted on Schedule "B" of this By-law.

- d) Map 12(6) is further amended by re-aligning the boundary of the GU sp:68 zone as depicted on Schedule "B" of this By-law.
- e) Map 12(6) is further amended by re-aligning the boundary of the GU sp:105 zone as depicted on Schedule "B" of this By-law.
- 3. This By-law comes into force in accordance with Section 34 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.




EXCERPT FROM MAP 12 (3)






