Dear Candidate/Agent,

Thank you for submitting the election sign application and deposit. With your application and registration now complete, we would like to provide you with a Candidate Welcome Package. This package includes important information to help you understand where election signs may be placed, along with key guidelines, best practices, and the “do’s and don’ts” to support you throughout the process.

Before placing signs, please review the map for your ward that designates arterial roads approved for election sign placement.

As a reminder, candidates and their agents are responsible for complying with the requirements of the [Sign By-law 2018-153](#), as amended. Here are some key points you need to know:

- No election signs of any kind are permitted until September 11, 2026 (45 days prior to Election Day).
- Election signs are restricted to designated arterial roadways only and are not allowed within road corridors abutting town owned facilities.
- Election signs must not obstruct the view of pedestrians or drivers or obstruct the visibility of traffic signs.
- Municipal Enforcement Services will be actively enforcing the placement of election signs.
 - Illegally placed signs will be confiscated and stored in a secure compound,
 - Signs may be retrieved upon payment of 60.00 fee per retrieval appointment, which will be deducted from your \$240.00 deposit.
 - Any signs not retrieved within 30 days after Election Day will be disposed of.
- All election signs must be removed within 72 hours of Election Day.
 - Any sign that is not removed within 72 hours of Election Day will be collected by Municipal Enforcement staff and a \$15.00 fee per sign will be deducted from your sign deposit.
- Steel T-bars shall not be used for installing election signs. When driven into the ground, they can cause significant damage to underground utilities (gas lines, hydro, and communication cables) . Damage to these utilities can be very costly, and candidates and/or their agents will be liable for all related repair costs. Approved sign supports for larger signs are: wood posts 2” (50 mm) x 2” (50 mm) or less.

- Signs that have been removed by Enforcement staff will be available for pick up **by appointment only**. Please contact Municipal Enforcement Services at 905-845-6601 x 7395 or email enforcement@oakville.ca to request an appointment to pick up the signs.

Please note the following as identified in Part 10 of the Town of Oakville's Sign By-law 2018-153 as amended:

- Notwithstanding Part 20, subsection 6 of this By-law, any election sign that has been seized and are not retrieved by the sign owner or the sign owner's authorized agent within 30 days of voting day may be destroyed by the Designated Official.

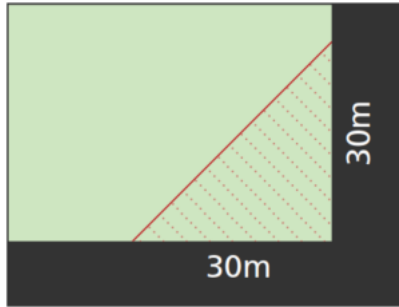

It is your responsibility, and that of your campaign team or agents, to ensure all signage is erected, displayed, and maintained in full compliance with [the by-law](#).

Information about sign permit requirements, along with the application form, is available on oakville.ca.

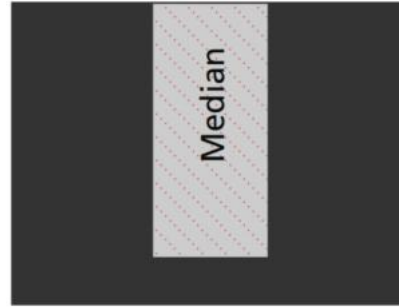
We trust you understand that these regulations are in place to protect public safety, maintain orderly streetscapes, and support fair and consistent election practices for all candidates and campaign volunteers.

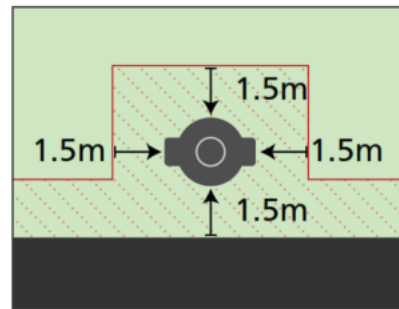

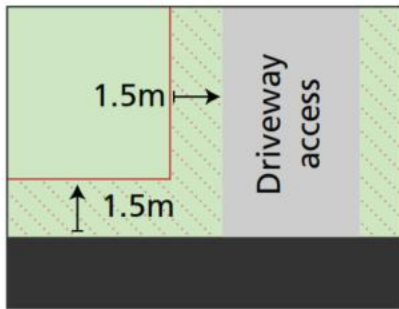

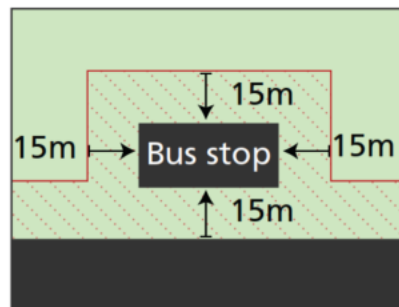

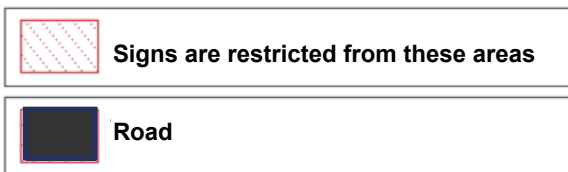

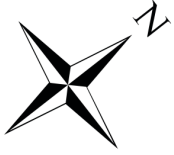

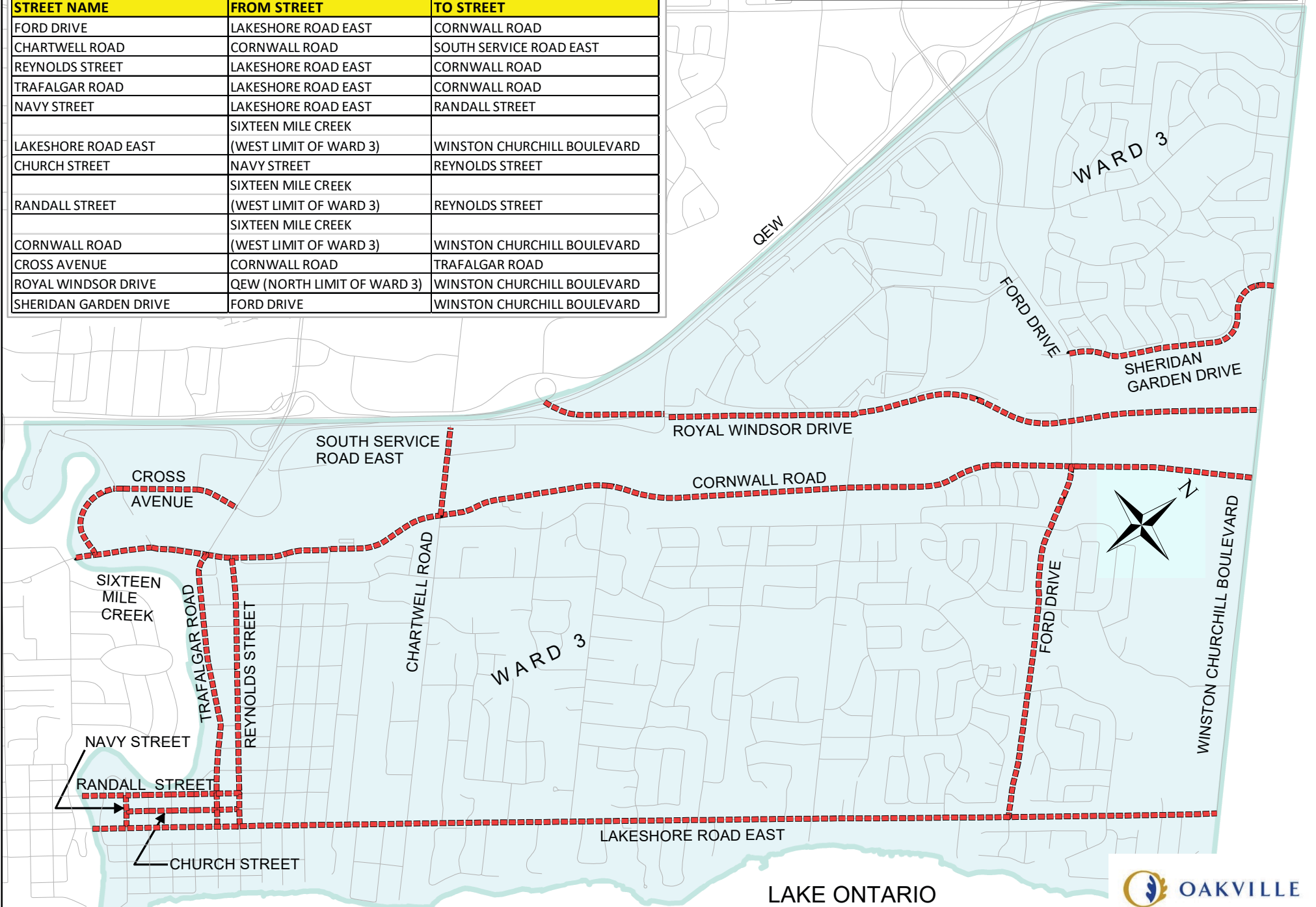

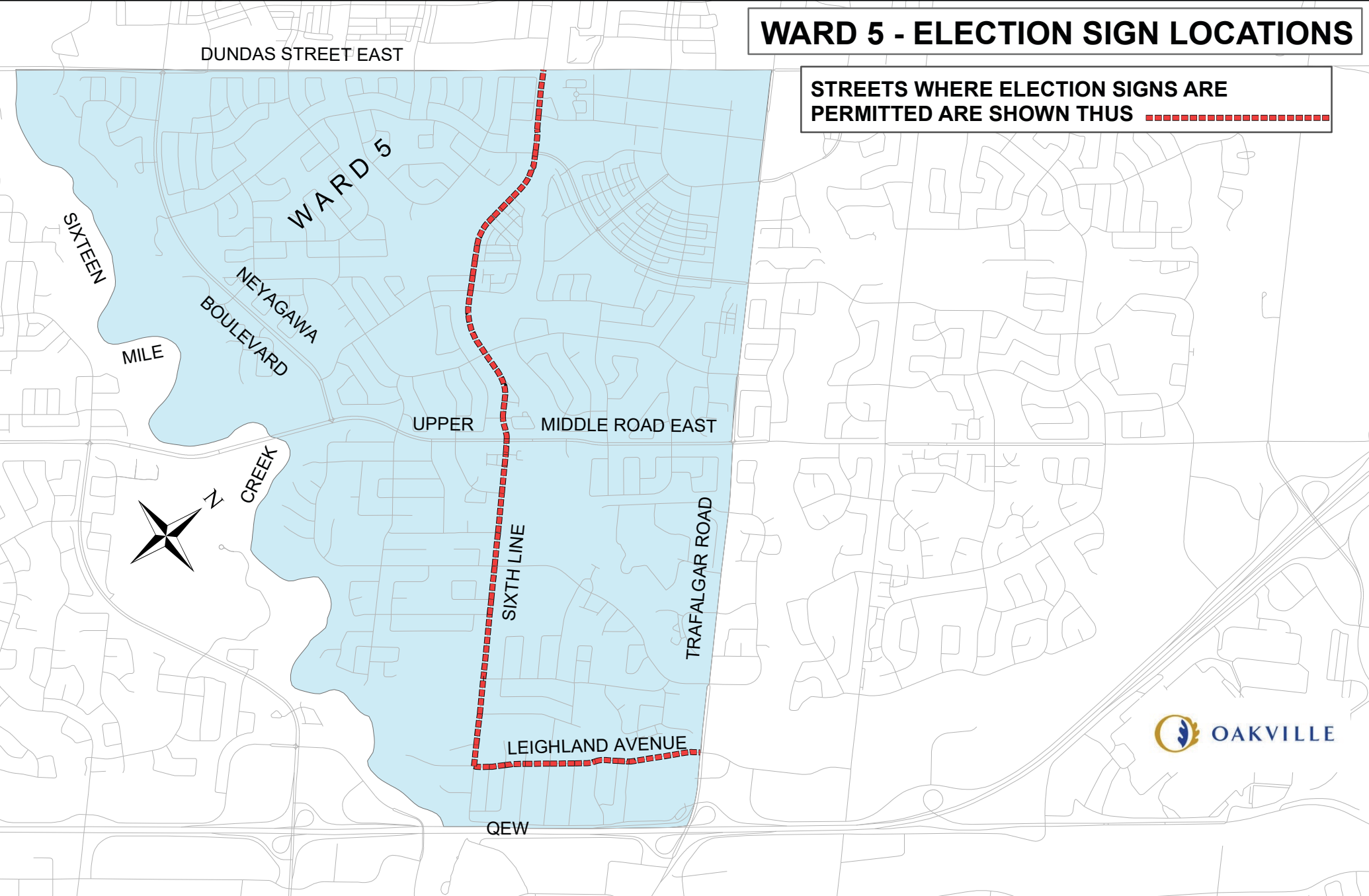
