





CONCRETE CURB AS PER TOWN




CONCRETE SIDEWALK AS PER TOWN






CIP CONCRETE SEAT WALL




LOCKSTONE PAVING ON/OFF SLAB

CIP PLANTER WALL





Tree Protection Barriers

1 Tree protection barriers must be 1.2m (4ft) high, waterboard incarding or an equivalent approved by Urban Forestry Services.

2 Tree protection barriers for trees situated on the Town road allowance where visibility must be maintained can be 1.2m (4ft) high, and consist of plastic web snow fencing on a wood frame made of 2'x 4's.

3 Where some excavate or fill has to be temporarily located near a tree protection barrier, phywood must be used to ensure no material enters the Tree Protection Zone. All susports and bracing should be outside the Tree Protection Zone. All sush supports should minimize damaging roots outside the Tree Protection Zone. All such supports should minimize damaging roots outside the Tree Protection Sone.


3 No construction activity, grade changes, surface treatment or excavations of any kind is permitted within the Tree Protection Zone.


