I hereby make application to the Town of Oakville Parks and Open Space Department to install and maintain a gate in the fence separating the above noted property from the adjacent municipal parkland property known as: Park Name:	

Installation and maintenance of such gate will be at my expense and will meet the Town of Oakville's Parks and Open Space department's specifications. The town shall be saved harmless from any claims or liability arising from the existence of such a gate.

MISUSE AND REMOVAL:

The gate is not to be used for access to town-owned lands for the purpose of dumping or other prohibited activities. I hereby agree to abide by all rules and by-laws as are effected to govern the maintenance and use of adjacent municipal parkland from time to time. If it is determined that the gate's existence is contributing to damage, or other adverse effects on the adjacent parkland, the Town will remove or seal the gate one month after written notice.

REVIEW OF GATE APPLICATION:

Gate access to the Town of Oakville's parkland is limited and considered a privilege. The Town of Oakville's Parks and Open Space department will review each application prior to either acceptance or refusal. A fee is required for the Gate Application Permit.

Note: Gate applications will not be considered onto naturalized (un-maintained, wooded or similar) areas, nor onto trails or pathways. The applicant is responsible for having underground service locates done before any digging can occur. ON1CALL (Ontario 1 Call) provides this free service and can be contacted at 1-800-400-2255. In addition, if the location of the proposed gate leads to a natural gas pipeline corridor, you will be required to contact the utility(s) to ask for their permission(s) and to advise that you will be placing fence posts in the ground in the vicinity of their easement(s) if permissions are given. Approval from Enbridge can be obtained by contacting Ann Newman, Crossing Co-ordinator at 519-339-0503. Utility contact information is also posted on signs along their corridor(s). Copies of Locate clearances and Utility approvals must be available on site for inspection by Town staff or its Agents.
